**POSITION: FORESTRY TEACHER – Philomath High School**

**QUALIFICATIONS:**

Oregon Certification in Forestry as determined by Oregon Teacher Standards & Practices Commission or extensive industry experience with the expectation of securing the appropriate Oregon Teaching Certificate. Additional endorsement preferred. Experience in FFA leadership desired.
